Rivers Summit III Presenter Highlights



CHRISTOPHER WINSLOW, PHD DIRECTOR, OHIO SEA GRANT COLLEGE PROGRAM

Dr. Chris Winslow Coordinates Ohio Sea Grant's Great Lakes research with agencies and universities, as well as assists in research, curriculum development, and student recruitment at The Ohio State University's Stone Laboratory. Earned his doctorate at Bowling Green State University, with research focusing on interaction between the native smallmouth bass and invasive round goby. For the past seven years, Winslow has been a fixture at Stone Laboratory, teaching Aquatic Ecology classes to high school and college students and mentoring college students and their Lake Erie research projects in the lab's Research Experience for Undergraduates Scholarship Program.

RICHARD BATIUK CO-FOUNDER, COASTWISE PARTNERS

Rich Batiuk was the associate director for science, analysis, and implementation at the United States Environmental Protection Agency's Chesapeake Bay Program Office located in Annapolis, Maryland. In his 33 years with EPA and working for the Chesapeake Bay Program partnership, he led the integration of science into multi-partner policymaking and collaborative decision-making. Working with academic, agency, advocacy and business experts, Rich was responsible for providing federal, state, regional and local partners and stakeholders with innovative technical and programmatic solutions to complex policy issues facing restoration and protection of the Chesapeake Bay ecosystem and the surrounding 41 million-acre watershed.



JEFF REUTTER BOARD MEMBER, FRIENDS OF STONE LABORATORY

Dr. Jeff Reutter is the former director of Ohio Sea Grant and Stone Lab. He currently acts as Special Advisor to the office, and continues to participate on regional, national and international advisory groups concerned with protecting Lake Erie. Jeffrey M. Reutter began working on Lake Erie at Stone Laboratory in 1971 and directed 4 programs at The Ohio State University from 1 November 1987 to 31 March 2015: F.T. Stone Laboratory, the Ohio Sea Grant College Program, the Center for Lake Erie Area Research, and the Great Lakes Aquatic Ecosystem Research Consortium, a consortium of top scientists at 12 Ohio colleges. He also served as acting director for all or parts of 1984, 85, and 86. When he retired as Director he accepted a part-time appointment as a Special Advisor for the programs.
